#### E44/04 **APOLOGIES FOR ABSENCE**

#### E45/04 **ORIENTEERING SCHEME ON MALTBY COMMONS**

Mr J Staveley and Mr C Dyson of Rotherham MBC in attendance.

Messrs Staveley and Dyson invited the Committee to fund the provision of an orienteering course on the Maltby Common for use by local schools, and the matter was discussed in detail.

**RECOMMENDED**: that the Town Council fund the provision of an orienteering course on Maltby Common to the value of £500 providing the use of the materials and the Common were controlled by Lord Scarborough's Estate Office.
